Course Rationale:

The study of sculpture is a unique endeavor requires students to master:

- Complex ceramic materials and techniques that are employed on a craft and industrial scale.
- A disciplined studio practice in which repetition and daily practice lead to complex skill acquisition.
- A cycle of aesthetic experimentation, analysis, and revision intended to generate aesthetically refined artworks.

This is an advanced course in sculpture. The artistic interests of the student will determine the nature of projects and research undertaken. The course provides the facilities, materials, experience, guidance, and community support required for a student to develop a professional studio practice. Students are required to be contributing members of the studio community.

Text requirements: There is no textbook for this course. There is a Materials fee assessed by the business office. Raw materials (clays, plaster etc.) are not to be taken from the classroom.

Concord University Educational Goal(s) Learning Outcome: An awareness of the aesthetic principles, methods, materials, and media employed in artistic performance and the creation of works of art and literature.

CLASS FORMAT:

This is an advanced course in sculpture. The artistic interests of the student will determine the nature of projects and research undertaken. The course provides the facilities, materials, experience, guidance, and community support required for a student to develop a professional studio practice. Students are required to be contributing members of the studio community.

Class meetings will include lecture, demonstration, critique, and time to work on projects. The majority of work will be completed outside of class. Vocabulary quizzes, and performance evaluations may be administered. sculpture involves a great deal of work and logistics. Sculpture students will be required to work outside of class. Students will be required to contribute labor to the class and classroom.

There will be five formal critiques. Students are expected to keep an activity log that documents their studio time.

Students will be expected to enter a juried art exhibition.

Specific Learning Outcomes:

-Students will demonstrate knowledge of general sculpture materials, technique, historic and contemporary trends

-The student will conceive and complete expressive objects.

-Students will grow creatively and artistically through the conception and execution of open-ended art assignments.

-Students are required to enter one juried exhibition before May 4. This will cost between \$20 and \$40.

-Students will be taking "ownership" of the studio. Students will be responsible for the cleaning and upkeep of the studio.

-Students will become familiar with basic conventions of display for art exhibitions.

-Students will demonstrate an ability to conduct artistic explorations in a self-directed, independent manner.

-Students will demonstrate an ability to be a contributing member of learning community.

-Students will become familiar with historic and contemporary sculpture trends.

-Students will become familiar with basic conventions of display for art exhibitions.

-The successful course participant will demonstrate an awareness of the aesthetic principles, methods, materials, and media employed in artistic performance and the creation of works of art and literature. Awareness of aesthetic principles, methods, materials, and media will be assessed through multiple choice exams, written essays, and the creation of sculptural art works.

Course Requirements: A grade of a C or better is required for credit for art majors.
