Course Description/Rational: This will be a comprehensive and engaging class that introduces cutting edge concepts in facilities and operation management with practical guidance from professional sport managers. Sport facilities of all shapes and size are an integral part of global sport management culture that are important area in sport careers.

- 6.0 Describe how to complete the approval process from bidding to complete construction.
- 7.0 Understand the different systems within a facility. (HVAC)
- 8.0 Describe day to day operations of a sports facility.
- 9.0 Describe various techniques used to present a safe, clean, and functional facility.
- 10.0 Develop strategies to reduce the carbon footprint of sport facility.
