**Course Description/Rationale: Course Description/Rationale:** This course will provide an introductory survey to core concepts of the science of psychology. As this is an introductory course, numerous topics will be discussed, though the course discussion of each topic is not designed to be in-depth. Prime objectives are for students to begin to develop critical thinking and writing skills as they apply to the fields of psychology and other sciences.

**Course Requirements:** The main portion of points from the course will come from exams. There will be four semester exams and one cumulative final. The exams will be mainly multiple choice, though other question types such as short answer are possible. Test questions may be comprised of any material covered in lecture, the text, or any assigned reading.

In addition to exams, you will be expected to complete one paper. The assignment is a 4 page (typed, double spaced) article comparison on a legitimate news article versus a non-legitimate news source on a topic in psychology of your choosing. The goal of this assignment is to begin to become familiar with topics in psychology that interest you, compare and contrast how different sources of information approach psychological topics, and to gain skills in formal writing at a college level. Details will be provided in class or on Blackboard. Late papers will be penalized 5% off the total score for each day they are late, including weekends, until they are deemed unacceptable by the instructor. **PAPERS ARE TO BE SUBMITTED ON BLACKBOARD.**

The final category applies to “active learning” experiences. You will be required to take part in **four (4)** of the activity types below and write a 1-2 paragraph synopsis of what you did and how it applies to psychology. You may do one (1) additional activity for extra credit. All activities are due by the last day of class, in class, no exceptions. If an option is not on the list below, just check with Dr. Falco. Some options:

- Watch a TED talk that we haven't seen in class that is related to psychology (**you may only watch and report on one talk**)
- Take part in a research project
- Go to an event (such as a talk or a film or a play) on campus
- Volunteer work with a campus group
- Research a psychological phenomenon and discuss it in your paper (**you may only do this project once**)
