Course Description/Rationale: "A general survey of western music from the Middle Ages to the present for students without a working knowledge of music fundamentals. Listening assignments, including attendance at selected concerts, may be included." -Concord University Academic Catalog

Music 101A online is an introduction to Western Art Music explored by studying the monumental works of major composers throughout history through a series of on-line components by publisher McGraw-Hill's Connect Software. This is an interactive guide that facilitates an active learning experience as you read the electronic text, *Music (An Appreciation)* by Roger Kamien. The learning modules help ensure a real-time comprehension of the material and will prepare you for an examination on each section of the text following the completion of each learning module.

We will begin by exploring the "Elements" Chapter that consists of the building blocks of all music. We will then survey the six periods of music (Middle Ages, Renaissance, Baroque, Classical, Romantic, and Twentieth-Century & Beyond) that western art music is divided into based on stylistic attributes. The course will end with a brief introduction of non-western music traditions.

Course Requirements, Grading Policy & Scale

1) Learning modules & Exams: This course consists of a series of **seven** on-line components called "learning modules," and **seven** "exams" based on each learning module.

As stated before, the electronic text chapters are divided thusly:

- Elements
- Middle Ages & Renaissance Periods
- Baroque
- Classical
- Romantic
- Twentieth-Century & Beyond
- Non-western Music

First, complete the learning module for "elements" and then the corresponding exam. Due dates are listed on Connect. Proceed in the order listed on Connect.

2) Discussion Group: Additionally, you will need to participate in the Discussion Group **THREE** times per question, for a total of **10** participation grades. When you respond to the discussion group you need to reply with an answer to the questions that I have posed and then to two of your colleague's posts. You need to demonstrate that you have completed the learning modules and have internalized the material by formulating a thoughtful and coherent response. Responses should consist of a minimum of three complete sentences. Answers such as "I agree with Jane" will not be acceptable and you will not receive participation credit.

3) Concert attendance: To bring together all the elements and eras that you are hearing and experiencing in the course you will need to attend **three** live classical or jazz concerts and write a 750-1,000 word description, review, of the event. You are responsible for finding appropriate events, but you may email me for clarification. Concert reviews should use the new terminology that you have garnered from this course. I have listed them as blogs in Connect. Describe the compositions, performers, and venue, as well as what you enjoyed or disliked about the event with appropriate musical terminology.

The FINAL GRADE breakdown for the course: 50% Connect learning modules & tests (7 modules and 7 exams averaged), 25% Discussion group participation, 25% concert attendance.
